1. Information We Collect

We collect the following personal information when you interact with Fynder:

- **Name:** To personalize communication.
- **Email Address:** To send property listings and updates.
- **Search Preferences:** To tailor property listings to your needs.
- **Payment Information:** For users who make purchases, processed through Stripe.

2. How We Use Your Information

We use your information for the following purposes:

3. Third-Party Services

We use third-party service providers to process your data:

- **Stripe:** We use Stripe to process payments. Stripe may collect your payment information and store your name, email, and payment

details in accordance with their privacy policy.

- **Mailgun:** We use Mailgun to send emails, such as property listings and updates.

These services are responsible for securing your information and comply with applicable laws and regulations regarding data protection.

4. Cookies and Tracking Technologies

We use cookies to:

- **Track Website Performance:** We monitor user interaction with our website to improve user experience and service performance.
- **Authenticate Users:** Cookies help to ensure that users are authenticated when they log into their accounts.

You can control cookie preferences through your browser settings. Please note that disabling cookies may affect your ability to use certain features of our website.

5. Data Sharing and Disclosure

We do not sell, trade, or otherwise transfer your personal information to outside parties, except for trusted third-party services that help us operate Fynder, such as Stripe and Mailgun.
